I refer to the above Clicks Trader Account with CIMB Bank Berhad [“CIMB Bank”] and hereby irrevocably instruct and authorise CIMB Investment Bank Berhad [“CIMB IB”] to utilise the available credit balance in the Clicks Trader Account as the trading collateral and settlement towards amount due in my Trading Account maintained with CIMB IB.

In view of the above, I hereby agree and consent to the disclosure by both CIMB Bank & CIMB IB of all information and transactions relating to the above-mentioned accounts to any securities exchange on which the transactions are effected [“Exchange”], regulatory bodies, or to any department or agency of any government having supervisory powers or jurisdiction over any Exchange on which I had traded or to the issuer of any of the securities purchased or sold by me.

Both CIMB Bank and CIMB IB may also disclose at your sole and absolute discretion any or all information in relation to or in connection with you or the above accounts maintained with you at any time and from time to time to your directors, officer, employees and representatives. For avoidance of doubt, CIMB Bank and CIMB IB may also disclose information to your related corporate and affiliates. For this purpose, “affiliates” means a related corporation (as defined in Section 6 of the Companies Act, 1965) of CIMB Bank & CIMB IB or a corporation in which CIMB Bank & CIMB IB own or control, directly or indirectly 20% to 50% of the equity of such corporation.

I also agree to adhere to the terms and conditions as laid out in CIMB Bank’s Terms and Conditions of Current Account with the following additions / exceptions:

1. Section 3, 5.1 & 8: Cheques – that this section shall not be applicable to the Clicks Trader Account as the cheque facility will not be extended to me
2. Section 4: subsections 4.3, 4.4 and 4.5 will not be applicable as withdrawal facilities via cheque, over-the-counter and ATM will not be extended to me
3. Further to Section 11: CIMB Bank reserves the option to discontinue the physical printing and mailing of the Clicks Trader Account statement while making available the statement information online at the CIMB Clicks platform. However, in this event, CIMB Bank shall also make available physical copies of the statement upon request.
4. Further to Section 12: The operation of a Joint account must be on the condition of “anyone” to authorise, not “and”.

In addition to the above, I shall not disrupt my trading with CIMB IB and/or settlement of any purchases and/or contra losses due to CIMB IB by keeping:

1. Minimum cash balance of RM10,000 (or any other amount may be determined by CIMB Bank & CIMB IB from time to time) is available in the Clicks Trader Account at all time to support my trading.
2. Sufficient fund in the Clicks Trader Account for settlement of any purchases and/or contra losses due to CIMB IB on settlement date.

I undertake to indemnify both CIMB Bank & CIMB IB and keep both CIMB Bank & CIMB IB indemnified from and against and in respect of all liabilities, losses, charges, expenses (including legal fees and costs on a full indemnity basis), claims, demands, actions and proceedings whatsoever which may be take against or incurred or sustained by CIMB Bank & CIMB IB directly or indirectly from or by reason of or in relation to or arising from or in connection with the above instruction and authorisation.
